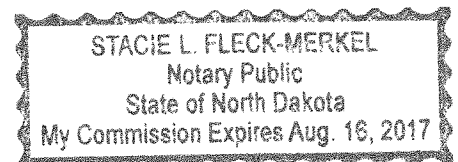

This supplement to the register (List of Certified Chemical Test Operators, July 1, 2014) shall be in effect until a new register is issued or until June 30, 2015, whichever is earlier.
