Dear Attorney General Wrigley:

Per N.D. Cent. Code §51-30-02, I am writing to you on behalf of Oakdell Egg Farms ("Oakdell") to notify you of a cybersecurity incident that may have exposed the personal information of a single North Dakota resident.

On February 15, 2022, Oakdell discovered that their network had been breached and confirmed the breach was part of a ransomware attack. Oakdell immediately initiated cybersecurity incident response measures, deployed a team of IT specialists, and engaged third-party cybersecurity forensic experts and other advisors to investigate, identify the scope of the incident, and implement measures to mitigate its impact. Oakdell also reported the incident to the F.B.I. and local law enforcement services.

Oakdell believes the outside attacker may have had the opportunity to access certain sensitive information that was being stored by Oakdell. The personal information involved in this incident may have included names, dates of birth, and government-issued identification numbers (for example, social security number or driver license number). The expected number of total affected users across all states is ~675.

Immediately upon discovery of the incident, Oakdell disconnected the infected computers from the network as a precautionary measure until additional protection measures were added. Oakdell is working with local law enforcement and the F.B.I. to investigate the matter. Oakdell also engaged legal counsel to help with our notification efforts. In addition, Oakdell is continuing to monitor suspicious activity on their systems and have deployed additional resources to reinforce the security of our systems.
