Ch. 12-60 (criminal history record information, §§ 12-47-36 (DOCR case history, medical, psychological, and treatment records), 27-20-51 (Juvenile Court records), and 27-21-12 (Division of Juvenile Services Records); 42 U.S.C. §§ 290-ee-3, 290-dd-2, and 42 C.F.R. Part 2 (drug and alcohol treatment and rehabilitation information); Rule 32(c), N.D.R.Crim.P. (Pre-sentence investigations); 45 C.F.R. Parts 160 and 164 (HIPAA Privacy Rule-Individually identifiable health information) 28 C.F.R. SUBPART C (U.S. Dept. of Justice Criminal History Record Information).</p>
