The Principal and Surety name above, who are authorized to engage in business in the State of North Dakota, are indebted to the STATE OF NORTH DAKOTA in the penal sum indicated above, and we bind ourselves, our heirs, executors, administrators, legal representatives, successors and assigns, jointly and severally firmly by this bond.

The above named Principal has applied, or intends to apply for a license as a Manufacturer of Electronic Pull Tab Devices pursuant to Section 99-01.3-16-01 of the North Dakota Administrative Code of the Games of Chance Administrative Rules and is required under the provisions of Section 99-01.3-16-01 to furnish a bond conditioned upon the manufacturer's faithful performance as a licensee and the manufacturer's subsequent support of existing electronic pull tab devices in the state at expiration or termination of the manufacturer's license, then this obligation shall be null and void; otherwise, it shall remain in full force and effect.

The Surety agrees that the obligation of this bond shall cover and extend to liability of the Principal effective as of the date above and shall continue in full force and effect until it is terminated or canceled, as provided herein.

The Parties further agree that:

Term of Bond: The term of this bond is for the one (1) year period from April 1 through March 31 of the current year and shall remain in effect for consecutive annual terms unless the Surety give ninety (90) days written notice by registered mail to the Principal and the Attorney General of the State of North Dakota. If the bond is terminated, the Surety shall remain liable under the provisions of this bond for any liability already accrued under this bond or which shall accrue before the expiration of the ninety day notice period.

Continuing Obligation: This bond is a continuing obligation and shall cover the full period or periods of licensing of the Principal including the present and all renewal licenses which said Principal may be granted; provided, that it is hereby expressly agreed that nothing contained herein shall be deemed or construed to reduce the liability of the Principal and Surety below the penal sum set forth above for which the named Principal shall be licensed, the same as if a new bond in the said penal sum were entered into for each and every separate period.

Duration of Bond: Bond shall not be revocable nor terminate prior to seven (7) years' time after the expiration of the license issued unless the Surety cancels this bond, as provided herein.

Beneficiaries: This bond is for the benefit of the State of North Dakota and any and all persons suffering damages by reason of Principal's failure to comply with North Dakota law or other legal obligations arising out of Principal's conduct as a Manufacturer of Electronic Pull Tab Devices.

Right to Bring Action: If the Principal violates Chapter 53-06.1 of the North Dakota Century Code, Article 99-01.3 of the North Dakota Administrative Code, or other legal obligations arising out of its conduct as a manufacturer of Electronic Pull Tab Devices, the State of North Dakota, as well as any person damaged as a result of such violation shall have, in addition to all other legal remedies, a right of action upon this bond for loss sustained by the injured party in any court having jurisdiction of the amount claimed for the recovery of any loss sustained.

Aggregate Liability: Regardless of the number of claimants, the amount of the claims, or the number of years the bond remains in effect, the aggregate liability of the Surety on this bond shall be limited to the payment of the penal sum set forth above.

Modification: The Principal and the Surety agree that they shall not amend, modify, or vary any term of this bond without prior written consent of the Attorney General of the State of North Dakota.

Warranties: The Surety hereby represents and warrants that it is in full compliance with the provisions of the laws of the State of North Dakota.

- 2) Valid power of attorney from the Surety must be attached.
