Said applicant is aware of all State and Local laws, regulations, ordinances and rules pertinent to the storage and sale of Class C fireworks which may be legally offered for sale and agrees to follow the laws of NDCC 23-15 and rules in Chapter 10-07-01 of the North Dakota Administrative Code regarding the storage, transportation, sale and usage of said fireworks.

Due to the nature of the business, applicant agrees to comply with all applicable administrative and statutory requirements, according to the type of sales conducted, including (but not limited to) the following:

- An automatic sprinkler system shall be installed in buildings storing over 500 pounds of fireworks (including packaging). **IFC 903.2.5**
- Storage of fireworks shall not be within 100 feet of residential buildings, school buildings, assembly occupancies, or within 50 feet of any inhabited building or roadway, and storage shall not be over 20 feet in height. **IFC 5601.2.1, IFC 5601.2.2, IFC 315.4, IFC 5601.8.1(3)**
- Smoking, open flames or spark-producing devices shall not be allowed within 50 feet of fireworks storage. **NFPA 1124 5.6.1**
- The area around fireworks storage shall be kept clear of brush, dried vegetation, leaves and similar combustibles for a distance of at least 25 feet. **NFPA 1124 5.6.2**
- Minimum sized 2A-10BC fire extinguishers are provided within 75 feet of any point in the retail sales area. Fire extinguisher must be accessible and annual maintenance properly documented. **IFC 906**
- Exit/Egress doors/spaces are at least 28 inches in clear width, require no more than 5 pounds of force to open, require a single action and no special knowledge of effort to open. Exits and means of egress are maintained free from any storage or impediments. **IFC 1104.7**

I hereby affirm that I have read the above rules, regulations and North Dakota state laws relating to the sale of fireworks and understand them. I also agree to post the license in a conspicuous place at each location from which I intend to sell fireworks.
