CITIZEN'S REQUEST FOR OPINION

This office received a request for an opinion under N.D.C.C. § 44-04-21.1 from S. Paul Jordan asking whether Bismarck-Mandan Mayors' Committee for People with Disabilities violated N.D.C.C. § 44-04-20(3) by failing to provide personal notice of upcoming meetings.

FACTS PRESENTED

The Bismarck-Mandan Mayors' Committee for People with Disabilities (Committee) works to "educate the public and initiate projects to establish a receptive climate for the involvement of people with disabilities in all aspects of life within the communities of Bismarck-Mandan." Members of the Committee are appointed by the Mayors of Bismarck and Mandan.² The Committee holds regular meetings on the second Tuesday in January, May, and September.³

ISSUE

Whether the Bismarck-Mandan Mayors' Committee for People with Disabilities violated open meeting laws by failing to provide personal notice to Mr. Jordan.

ANALYSIS

A governing body must post notice of meetings in compliance with N.D.C.C. § 44-04-20 which includes providing personal notice of meetings to individuals who request to

receive such notice.⁴ No one from the Committee received a request from Mr. Jordan for personal notice of any upcoming meeting.⁵

CONCLUSION

The Bismarck-Mandan Mayors' Committee for People with Disabilities did not violate open meetings law because it never received a request from Mr. Jordan to provide notice of upcoming meetings.
