#### • CJIS Brief Status

- <u>Budget</u>: Molly Goebel provided an update on the ND CJIS budget. There are no budget concerns for the current biennium at this time.
- <u>Projects</u>: Molly Goebel and Heidi Smith provided updates on ND CJIS projects.
- <u>Outreach</u>: Heidi Smith reported there continues to be significant contact with ND CJIS stakeholders.
- <u>Operations</u>: Heidi Smith reported that overall the operations of each program are running smoothly. Two staff positions are in the process of being filled.

#### • Fingerprint-Based Background Check Audit Findings

 Molly Goebel and Mike Lynk discussed potential audit findings for agencies providing access to records management systems without fingerprint-based background checks.

#### • Roundtable Discussion of Current Agency Projects

- Kara Schmitz-Olson (Cass Co. State's Attorney/ND State's Attorney Assoc.): Cass County is having some struggles with implementing CST, but CJIS staff members have been helpful.
- Jim Remer (Grand Forks PD/League of Cities): Grand Forks PD will be setting up more reports in P1 LERMS and is looking at reworking a portion of the CAD interface.
- <u>Mike Lynk (State Radio/DES)</u>: The Game & Fish message key is going into NCIC and the message switch. State Radio is working through issues related to defense attorneys requesting discovery. State Radio is hoping to get corrections photos into NLETS when funding is found.
- <u>Dan Sipes (ITD)</u>: Microsoft is interested in being CJIS-certified for North Dakota state government use so law enforcement can use Cloud services.
- Frank Senn (Beulah PD/Chiefs of Police Assoc.): Nothing to report.
- <u>Sally Holewa (ND Judicial Branch)</u>: The e-charging project continues to be a priority.
- <u>Russ Buchholz (DOT)</u>: Beginning in mid-August, driver's license renewals will be available online when certain requirements are met.
- <u>Dallas Carlson/Lonnie Grabowska/Molly Goebel (BCI)</u>: BCI continues to work on Rapid ID, concealed weapons licensing, criminal history and 24/7 sobriety program software.
