APPROVED-FOR-SALE TOBACCO PRODUCTS DIRECTORY

Updated May 2, 2024

N.D.C.C. ch. 51-25.1 requires the Office of the North Dakota Attorney General to publish a directory of cigarettes and roll-your-own tobacco products that are approved to be sold, offered for sale, or possessed for sale in the State of North Dakota. Any brand not listed in this directory is considered contraband that is subject to seizure and forfeiture.

Under N.D.C.C. § 51-25.1-02(5), a person is deemed to have received notice that cigarettes of a tobacco product manufacturer or brand family are not included in the directory at the time this website fails to list the tobacco product manufacturer or brand family in the directory, or at the time the tobacco product manufacturer or brand family is removed from the directory.

Effective May 2, 2024, at the request of tobacco product manufacturer R.J. Reynolds Tobacco Company, the Attorney General’s Office REMOVED the Dunhill, Dunhill International, and State Express 555 brands from the Approved-For-Sale Tobacco Products Directory below.

Effective May 2, 2024, at the request of tobacco product manufacturer NASCO Products, LLC, the Attorney General’s Office REMOVED both the tobacco products manufacturer NASCO Products, LLC and its SF and VLN brands from the Approved-For-Sale Tobacco Products Directory below.

Effective September 29, 2023, at the request of tobacco product manufacturer Philip Morris USA Inc., the Attorney General’s Office REMOVED the Cambridge brand from the Approved-For-Sale Tobacco Products Directory below.
