Director Hummel provided an update regarding the Gaming Division's upcoming computer system transition.

6. Public Hearing – North Dakota Games of Chance Administrative Rules

Chairman McLean opened the public hearing at 1:08 PM pursuant to NDCC § 28-32-11 for the purpose of allowing individuals the opportunity to submit information and comments regarding proposed amendments to N.D. Administrative Code Article 99-01.3 – Games of Chance.

The hearing followed publication of the Full Notice of Intent to Adopt and Amend Administrative Rules dated January 20, 2026. The purpose of the hearing was to ensure the public had the opportunity to provide comments, data, views, or arguments prior to adoption of administrative rules as required under NDCC Chapter 28-32.

7. Overview of Proposed Rule Changes

Gaming Director Aaron Hummel presented an overview of proposed amendments to numerous sections of N.D. Administrative Code Article 99-01.3 – Games of Chance including provisions related to definitions, licensing, permits, record checks, equipment acquisition, gaming accounts, recordkeeping requirements, raffle ticket requirements, electronic pull-tab devices, sports pools, surveillance systems, poker tournaments, and eligible uses of gaming proceeds.

The proposed rules are expected to have an impact on the regulated community in excess of \$50,000 and implement legislation enacted during the most recent legislative session including House Bill 1192, Senate Bill 2334, House Bill 1504, and Senate Bill 2288.

8. Public Comment

In-person and written comments were received from the following individuals:

Marietta Fiddler – Comments regarding definitions for Level 1, Level 2, and Level 3 games and concerns regarding gaming vouchers.

Bill Kalanek – Chairman, North Dakota Gaming Advisory Council. Written comments regarding multiple rule sections including site authorization, kiosks, raffles, poker

limits, and eligible uses.

Karen Breiner – Gaming Manager, Bismarck-Mandan Convention and Visitors Bureau. Comments regarding provider responsibilities, charity audit requirements, and dealing mistakes.

Janelle Mitzel – Charitable Gaming Association of North Dakota. Written comments regarding site authorization, restrictions, electronic pull-tabs, chips, dealing mistakes, and eligible uses.

Senator Dick Dever – Commander, AMVETS Post #9. Requested utilities and insurance be considered eligible uses for veterans clubs.

Scott Meske – Lobbyist, North Dakota Gaming Alliance. Written comments regarding site authorization, kiosks, eligible uses, and lessor restrictions.

Don Santer – CEO, North Dakota Association for the Disabled. Requested electronic forms and changes to audit rules for bar employees.

Rudie Martinson – Executive Director, North Dakota Hospitality Association. Requested bars be allowed to advertise gaming and suggested monetary fines as alternatives to suspension of gaming.

9. Commission Discussion and Action

No action was taken at this time regarding the administrative rules.

The next meeting of the North Dakota State Gaming Commission is tentatively scheduled for April 1, 2026.
