The minutes referenced above reflect award amounts that were initially approved by the DVC Policy Board based on estimated funding levels. Due to the government shutdown, the North Dakota Attorney General's Office was required to project anticipated award amounts prior to official notification.

On March 13, 2026, the Office of Justice Programs' Bureau of Justice Assistance announced the availability of funding under the FY25 Edward Byrne Justice Assistance Grant (JAG) Program. The actual award received exceeded the original estimates.

On March 24, 2026, North Dakota Attorney General Drew Wrigley approved the following revised award amounts:

ND Office of Attorney General, Bureau of Criminal Investigation-Agent Grant
